



XAT EXAM PREPARATION 2026

Overall, XAT exam pattern is quite different from CAT exam. XAT exam pattern is designed to assess a candidate's decision-making/ analytical-thinking, language skills, quantitative aptitude, and general knowledge. The XAT 2026 exam pattern comprises a total of 95 questions spread across four key sections. These include Decision Making (21 questions), Verbal and Logical Ability (26 questions), Quantitative Ability and Data Interpretation (28 questions), and General Knowledge (20 questions). Each question carries one mark, making the total to 95 marks. Note that XAT Essay Writing section was removed from XAT 2025 exam pattern. Check table below for a clear understanding.

Toppers Tips for XAT VALR Preparation

- **Daily Newspaper Reading for RCs & Poems:** Reading editorials from quality newspapers helps build comprehension. Says Nipun Garg (XAT Topper 99.95%; XLRI PGDM-BM 2023-25), "My main source for preparation of the VA section was the daily newspapers (mainly *The Hindu* or *Indian Express*). Apart from that, one of

the main things anyone should focus on is to read the RCs and poems in the exam extremely carefully before attempting.”

- **Regular Practice with Short Passages:** Consistent effort and timed practice can boost accuracy in VA. Says Harsh Gupta (XAT Topper 99.99%; XLRI PGDM-BM 2023-25), “For verbal, I was mainly studying from online available sources... I was regularly reading short passages on diverse topics and I had set a fixed timing of 1.5-2 hrs every day to spend on verbal section solving RCs and critical reasoning questions.”
- **Focus on Understanding, Not Just Speed:** Clarity of thought helps avoid silly mistakes. Says Harsh Gupta, “My major focus in verbal was to ensure that I can understand the meaning of the passages and poems and don’t make silly mistakes during examination.”

XAT Preparation 2026 for Decision Making Section

Decision Making (DM) is a unique section in Xavier Aptitude Test (XAT). It tests your ability to holistically view a situation and propose a solution to a problem. DM also tests you on your ethical standing. To prepare well for this section, you should know exam pattern and syllabus. Check complete details below. XAT preparation tips by toppers follow pattern and syllabus.

XAT 2025 Decision Making Section: Type of Questions

This section consisted of 21 questions. The section consisted of 7 sets of 3 questions each. Some questions were ambiguity with no clear “correct answer”. XAT 2024 DM Section break up is also given below.

While XAT DM section does not have any specific syllabus, based on past papers, this can be considered as XAT DM syllabus.

- Analytical Reasoning Decision Making
- HR related Decision Making
- Ethical Issues Decision Making
- Mixed Issues related to above dimensions

a) Analytical Reasoning Decision Making: Focuses on evaluating and interpreting data, identifying patterns, and solving logical dilemmas.

Key Topics:

- Logical consistency and argument evaluation
- Cause and effect relationships
- Dilemma-based scenarios
- Prioritization and sequencing tasks
- Data sufficiency and interpretation
- Evaluating multiple options under constraints

Example: Choosing the best strategy for product pricing based on market data.

b) HR-Related Decision Making: Tests understanding of organizational behavior, employee management, and workplace dynamics.



Key Topics:

- Recruitment and selection dilemmas
- Performance evaluation and appraisal
- Promotions and internal conflicts
- Conflict resolution in teams
- Workplace policy decisions
- Handling diversity and inclusion

Example: Deciding whether to promote a high-performing but controversial employee.

c) Ethical Issues Decision Making: Assesses ability to make morally sound choices in ambiguous or high-stakes situations.

Key Topics:

- Ethics vs. profitability
- Confidentiality and transparency
- Conflict of interest
- Corporate social responsibility
- Fair treatment and justice
- Whistleblowing scenarios

Example: Choosing between reporting a colleague's misconduct vs. team loyalty.

d) Mixed Issues (Analytical + HR + Ethical): These scenarios combine multiple dimensions, requiring integrated thinking and balanced judgment.

Key Topics:

- Navigating conflicts that involve HR, ethics, and logic
- Trade-offs between ethical integrity and business goals
- Multifaceted problems with both qualitative and quantitative aspects
- Situational judgment with limited information

Example: A team lead must balance employee morale, project deadline, and compliance with a new corporate directive.

Toppers Tips for XAT DM Preparation

- **Practice Past Year Papers Thoroughly:** Consistent practice with previous DM sets is crucial. Says Nandagopal V (XAT Topper 99.99%; XLRI PGDM-BM 2023-25), “To prepare for DM, my recommendation would be to practise previous year papers, as many times as you want, specifically the DM section.”
- **Match the Examiner’s Perspective:** Understanding the expected logic behind answers is key. Says Nandagopal V, “Each of us has a unique perspective... Unless this perspective matches with the examiner’s, there is no point in our justifications.”
- **Discuss Case Studies with Peers:** Peer discussions can reveal alternate, valid interpretations. Says Nipun Garg (XAT Topper 99.95%; XLRI PGDM-BM 2023-25), “I also relied on few of my friends to discuss the given case studies to gain a different perspective.”
- **Focus on Logical Deduction:** Understanding the rationale behind correct answers improves accuracy. Says Nipun Garg, “I tried to deduce logically why the given answer was correct.”

XAT Preparation 2026 for Quantitative Ability & Data Interpretation Section

Quantitative Ability & Data Interpretation (QADI) section in XAT assesses the foundational understanding of arithmetic, algebra, geometry, mensuration, modern maths. The questions on DI are about clear interpretation, summarization, and insightful analysis of the data. To prepare well for this section, you should know exam pattern and syllabus. Check complete details below. XAT preparation tips by toppers are also given.

XAT 2025 Quantitative Ability & Data Interpretation Section: Type of Questions

In XAT 2025 exam, out of the 28 questions in the section, 16 questions were on Quantitative Ability and 12 questions were on Data Interpretation. In Quantitative Ability section there were questions from Arithmetic, Geometry, Modern maths, Algebra and Numbers. Check break up below. There were four sets of Data Interpretation with 3 questions in each set. Details are given below.

Toppers Tips for XAT Quantitative Ability & Data Interpretation Section

- **Practice Geometry and Mensuration:** These often-ignored topics can be game-changers. Says Nandagopal V (XAT Topper 99.99%), “The competitive advantage of putting in the extra hours in them are two-pronged... you might know some theorems which that can help you solve these questions really fast, thus saving time.”
- **Use Reliable Prep Books:** Structured materials help build core concepts. Says Nandagopal V, “I prepared for the QA section in CAT by practising questions from the Arun Sharma book.”
- **Daily Practice Across Topics:** Consistent variety keeps concepts fresh. Says Harsh Gupta (XAT Topper 99.99%), “My major preparation strategy for this section was to solve a set of diverse questions covering all major domains every day to retain concepts in my mind.”
- **Smart Question Selection in Exam:** Attempt familiar topics first to optimize time. Says Harsh Gupta, “In final exam I attempted the questions of topics I was most comfortable in and rest I attempted only after I had solved everything else.”

XAT Preparation 2026 for General Knowledge (GK) Section

General Knowledge section has 20 questions in XAT 2025 exam. The score in this section is not taken into account for percentile calculation in XAT exam. However, during XLRI PI Round GK plays an important role in final selection. In-depth and regular reading of GK helps more as sometimes a few GK questions in XAT appear trickier and need intensive reading. Below is shared the topic wise XAT entrance exam GK syllabus on which questions were based in XAT 2024 in this section.

Toppers Tips for GK Preparation for XAT 2026

2. **GK Matters Beyond Percentile:** Even though it doesn't impact your XAT percentile, it plays a key role in XLRI admissions. Says Kanika Mehra (XAT Topper 98.32%), "Although GK score is not counted in percentile preparation, it plays important role in XLRI admission."
3. **Leverage Newspaper Reading:** It boosts not just GK but also essay and interview prep. Says Kanika Mehra, "Try reading a newspaper every day... it will help you with your VARC, essay and interview as well."
4. **Pick the Right Publications:** Quality of source matters. Says Kanika Mehra, "Pick up something like *The Hindu*, *Mint* or *Indian Express*. Read editorials in these papers."

XAT Preparation Strategy 2026

Cracking XAT requires focused preparation across three core sections: Verbal Ability, Decision-Making, Quantitative Ability. General Knowledge section is not used for calculating percentile but must not be ignored. These XAT preparation tips can help you maximize your performance.

- **Understand the Exam Pattern and Syllabus:** As detailed above, familiarize yourself with the XAT syllabus and sectional structure. Knowing the number of questions in each section will help you prioritize your preparation.
- **Focus on Decision-Making:** Practice decision-making caselets daily, as this section is unique to XAT. Review past years' papers to identify common patterns and improve your problem-solving approach.
- **Enhance Verbal Reasoning:** Develop critical reasoning and comprehension skills by reading diverse materials. Focus on tackling RC passages, grammar questions, and logical reasoning problems.

- **Strengthen Quantitative Ability:** Concentrate on key areas like arithmetic, algebra, and geometry. Regularly solve practice problems and take timed mock tests to boost speed and accuracy.
- **Brush Up your General Knowledge:** Follow current affairs and static GK topics, covering both national and international news. Review business and economic developments relevant to economy and business.
- **Take Regular Mock Tests:** Take full-length mock tests and analyze your performance after each. Focus on understanding errors and improving time management for each section.
- **Finally, Manage Stress:** Don't let the exam stress overpower you. Manage it with daily smart preparation and stress busters like music and exercise.
